DEXCOM 360 PROGRAMME AGREEMENT

By signing this agreement, I acknowledge that in return for lower than the retail list price, I am committing to a 12-month subscription to purchase Dexcom G6 from New Zealand Medical and Scientific Limited (NZMS) and agree to the following terms and conditions:

1. Term

The term of this agreement will be 12 consecutive full months from the First Payment Date (as that term is defined in paragraph 3 below) as per the shipping and payment schedule set out in Schedule 1.

2. Collection and Use of Information

I authorise NZMS to collect, retain and use any information about me, for the purpose of assessing my credit worthiness and enforcing any rights under this Agreement. In accordance with the Privacy Act and the Health Information Privacy Code 2020, please find NZMS Privacy Policy outlaid here <https://nzmsdiabetes.co.nz/privacy-policy/>

3. Payment

NZMS is authorised to take the first payment due under this Agreement on the first working days after the date of this Agreement. First Payment Date shall be defined as the date on which cleared payment is received by NZMS.

4. Early termination

If this agreement is terminated prior to expiry of the 12 month term, I acknowledge that an early termination fee as per the early termination fee schedule set out in Schedule 2 shall become immediately due and owing to NZMS. NZMS reserves the right to immediately charge the balance of the subscription due under this Agreement to the credit card provided under this Agreement.

5. Temporary suspension of subscription

NZMS understands that personal situations may change which can impact on your ability to meet the obligations of this Agreement. During the term of this Agreement, you may, by written notice to NZMS, temporarily suspend your subscription for a period not exceeding three months by giving NZMS a minimum of one month's notice. During the period of temporary suspension, you will not receive any Dexcom products under this Agreement. Once the suspension period has ended, the payment and shipping schedule will automatically resume and the subscription term will be extended by the same period of time as the duration of the temporary suspension. If the temporary suspension has resulted in you requiring additional Dexcom supplies to resume using the Dexcom system in full, this will be at cost to you at standard list pricing and NZMS will not be obligated to provide any additional products outside of Schedule 1 under this Agreement. A subscription plan can only be temporarily suspended once for the duration of the Agreement term under this clause.

6. Payments

I agree for NZMS to charge the credit card (as provided on page one of this Agreement) 12 consecutive monthly charges of \$379.50 (including GST) as set out in schedule 1 to be charged on the monthly anniversary of the First Payment Date for the balance of the term of this Agreement.

I understand that payment at the start of the agreement term will be required prior to any product being shipped to me. I also understand that subsequent deliveries as per Schedule 1 will only be made following receipt of payment by NZMS. I acknowledge that failure to make a monthly payment without prior written notification to NZMS may, at the discretion of NZMS, be considered as an early termination of this agreement in which case I acknowledge that I will be liable to pay the early termination fee as set out in Schedule 2. I acknowledge I will be responsible for payment of any and all credit card surcharge fees and hereby authorise NZMS charge such fees to my credit card in addition to the payments for the product due under this Agreement.

I acknowledge that the payments 12 monthly payments due under this Agreement are exclusive of shipping and I hereby authorise NZMS to charge to my credit card all shipping costs associated with the product being shipped to me.

I confirm I have the authority of the credit card holder (if that is not me) for the card to be charged by NZMS for these payments.

7. Default

In the event of default by me under this Agreement, then NZMS shall have the right to charge interest accruing daily at the rate of 15% per annum on all amounts which are unpaid by the due date. This shall be payable on any monies outstanding under this Agreement from the date payment was due until the date payment is received by NZMS but without prejudice NZMS's other rights or remedies in respect of my default in failing to make payment on the due date. Any fees or expenses incurred in effecting the collection of accounts in default of this condition (including solicitor/client costs) will be added to the amount owing. Credit card payments may incur a credit card surcharge fee.

8. Delivery

NZMS shall deliver the products as set out in schedule one of these terms to the delivery address recorded on page one. I acknowledge that I will advise NZMS in writing of any change to my delivery address and shall provide NZMS at least 5 working days' notice of any change to my delivery address.

9. Return of the goods

In the event the products are not of acceptable quality, NZMS must require return of the products and NZMS will within 10 working days of return of the products at its option repair, replace the same, or refund the associated purchase price.

10. Notice of defects

You must have regard to the nature of the products, and the price, and consider any statements on the packaging or labels or by the manufacturer on the goods, or by NZMS at the time of purchase, and any specific defects of the goods drawn to your attention.

11. Other agreements

I acknowledge I must use the goods in a reasonable manner having regard to their nature.

12. Product Support

This agreement includes the following local support (as may be required):

- (a) 24-hour 0800 technical support;
- (b) In-person specialist local training from a New Zealand field agent;
- (c) Replacement sensors if there is a fault or at the discretion of NZMS in cases of training issue

13. Limitation of Liability

NZMS will not be liable for any loss, damage or injury caused to you or other persons.

For all other liability arising in connection with these terms and conditions (including but not limited to breach of contract, tort, negligence or under an indemnity), then to the extent permitted by law, NZMS's liability is

limited to an amount equal to the sum paid by you to NZMS for the Services.

You agree to indemnify NZMS against all losses and expenses which NZMS may suffer or incur due to your failure to observe your obligations under this Agreement and any claims made against NZMS by any third party in respect of any loss, damage, death or injury arising from the subject matter of this Agreement.

To the extent permitted by law all causes of action against NZMS, arising out of or in connection with the provision of the products under this Agreement expire upon the termination of this Agreement. NZMS shall not be liable for any failure of any guarantee made by a manufacturer of goods other than as stated on the packaging or label.

14. Variation

Any variation to this agreement including to the payment and delivery schedule can only be made by prior agreement from NZMS and is to be recorded in writing between you and NZMS.

15. Renewal

This Agreement can be renewed with written agreement of both parties at the expiry of the current Agreement term and such may include different terms than this Agreement, including but not limited to alteration to the price.

16. Termination

This Agreement will automatically terminate at the end of the Agreement term unless renewed in accordance with section 15 of this Agreement.

17. Waiver

These terms and conditions remain in force notwithstanding any neglect, forbearance or delay in enforcement. NZMS shall not be deemed to have waived any term or condition unless such waiver shall be in writing and signed by a director of NZMS and any such waiver shall apply only to the particular transaction to which it refers.

18. Severability

If any clause or provision of these terms and conditions shall be held illegal or unenforceable by any judgment of any court or tribunal having competent jurisdiction, such judgment shall not affect the remaining provisions hereof which shall remain in full force and effect as if such clause or provision held to be illegal or unenforceable had not been included herein.

19. Governing Law

These terms and conditions will be interpreted in accordance with New Zealand legislation, which will have exclusive jurisdiction over any dispute in relation to the products or these terms and conditions.

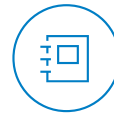
